

#### FFRAGO 14 TO HODA EXORD 210-20 COVID-19 TRANSITION FRAMEWORK

(FOUO), Among other items included in this FRAGO is the following:



- 3.D.29.A.[RESTATED] Effective for travel commencing after 300001R Aug 20 Soldiers, DA civilians, and family members under the jurisdiction of the SECARMY conducting official travel from the US and its territories to another country will have a negative COVID-19 test result (or medical clearance IAW 3.D.29.A.2) before departing home station or a CONUS replacement center. The negative test result or medical clearance must be received as close as possible to departure from home station or CONUS replacement center.
- ◆ 3.D.29.A.4.A.) [ADD] Army personnel, family members and DA Civilians on PCS or TCS orders to another country that have tested positive for COVID-19 will isolate at their residence or other appropriate domicile until medically cleared to discontinue isolation. Personnel will not travel for at least 14 days after receiving a positive test result. At the 14 day mark from a positive test, these patients should be medically cleared by their local medical treatment facility for onward movement. A second COVID test is not required for movement after the 14-day wait period is complete. This policy replicates the Korean CDC's policy that established a 14 day medical clearance timeline for Korean and international patients arriving COVID-19 positive in Korea.

ALARACT 080/2020, URGENT - UPDATE ARMY GUIDANCE FOR FILING PERMANENT CHANGE
OF STATION (PCS) AND TEMPORARY DUTY (TDY) TRAVEL CLAIM FOR SOLDIERS IMPACTED
BY THE CORONAVIRUS DISEASE 2019 AND MILITARY PAY AND ALLOWANCES FLOWCHART

(FOUO). This ALARACT replaces ALARACT 029/2020 and provides clarification guidance for filing PCS or TDY travel claims when Soldiers and/or dependents travel was impacted by COVID-19 in accordance with the provisions set forth in ALARACT 054/2020. It further clarifies the restriction of movement requirement and impact to entitlements. Included as attachments are COVID-19 Pay And Allowances Flowchart, 28 SEP 20, Sample DD Form 1610 (COVID-19 Travel Delay), Sample DA Form 4187 (Personnel Action), and Military Pay E-Message 20-018, Subject: Hardship Duty Pay – Restriction of Movement Due to COVID-19 (HDP-ROM).

# MILPER MESSAGE 20-344, FISCAL YEAR 2021 (FY21) ACTIVE COMPONENT (AC), LIEUTENANT COLONEL (LTC), MEDICAL CORPS (MC), AND DENTAL CORPS (DC), PROMOTION SELECTION BOARDS (PSB) ZONES OF CONSIDERATION,

Subject selection board will convene on 20 Jan 21 to consider eligible Majors (MAJ) on the Active Duty List (ADL) for promotion to LTC. The board will recess on or about 28 Jan 21.

# MILPER MESSAGE 20-345, CHANGE TO CONSOLIDATED ENLISTED PROMOTIONS EXCEPTIONS TO POLICY GUIDANCE DURING THE CORONAVIRUS (COVID-19) OUTBREAK.

Effective with the November 2020 promotion month, the previously approved limited application of exceptions to policy (reference J) suspending requirements to complete requisite professional military education (PME) course to fully qualify for promotion is rescinded. Promotion to all noncommissioned officer ranks, across all military occupational specialties (MOSs) require Soldiers to be fully qualified, to include completion of the requisite PME course. The previously published PME exception to policy program for deployed NCOs is reinstated across all MOSs.

#### FIGHT COUNTERPRODUCTIVE THINKING BY USING REAL-TIME RESILIENCE.

#### IMPLANT SCREW TORQUE VALUES AND ZIRCONIA ABUTMENTS


- The ADL is fabricating implant abutments in house. Screw torque values for single crown restorations continue to be 20 Ncm for Zimmer Biomet implants and 35 Ncm for Nobel Biocare implants. There has been no change. If a screw needs to be replaced, an OEM screw can serve as the replacement.
- · Screw torque values for all Nobel Biocare and Zimmer Biomet restorative components are in the attached PDF's

#### **Nobel Biocare Torque PDF**

#### **Zimmer Biomet Torque PDF**

- Prosthetic components for other implant systems may require different torque values. Always consult the
  respective instructions for use.
- For Nobel Biocare ZIRCONIA ABUTMENTS for CONICAL CONNECTIONS, unless a zirconia connection is requested in the Labtrac Rx, ALL connections will default to a titanium connection. The abutment screws for the zirconia abutment with a titanium connection will require the Omnigrip driver from Nobel Biocare (driver used with angulated screw channel restorations).
- When the zirconia abutment for conical connections has no metal connection, use the Unigrip driver.
- TRILOBE connections with the titanium connection will still require the Unigrip driver.

COL Christopher Jenkins is retiring from Active Duty
November of 2020 after having served for over 30 years in the
Army Dental Corps, culminating as the Chief and Program
Director of the San Antonio Military Medical Consortium
(SAMMC) Oral and Maxillofacial Surgery Residency.

COL Jenkins started his Army Dental career in August of 1984 after completing Basic Training at Fort Dix, New Jersey and being assigned as a 68E Dental Specialist to the 101st Airborne Division, Fort Campbell, Kentucky. COL Jenkins completed dental school at the University of Michigan under the Health

Professions Scholarship Program (HPSP), graduating in 1993. He was selected and completed the 1-Year Advanced Education in General Dentistry Residency (1YR-AEGD) at Fort Carson, Colorado. His first tour as a General Dentist took him to Vilseck, Germany as the Brigade Dental Surgeon for the 201st Forward Support Medical Company where he deployed to Croatia in support of Operation Joint Endeavor April-July1996. In 1997, COL Jenkins Started the 6-year dual-degree Oral and Maxillofacial Surgery Program at the San Antonio Uniformed Services Health Care Consortium (SAUSHCC), graduating in 2003. Dr. Jenkins is one of only nine Army Oral Surgeons to have earned the Doctor of Medicine degree upon graduating from his Oral and Maxillofacial Surgery Residency. COL Jenkins deployed with the 10th Combat Support Hospital (CSH) to Baghdad, Iraq as the Theatre Consultant in Oral and Maxillofacial Surgery November 2008 through June 2009. Since his return from the combat zone, COL Jenkins has dedicated his life to mentoring Army Oral and Maxillofacial Surgery Residents. He has served three years as the Chief and Program Director of the Eisenhower Army Medical Center OMS Residency Program, Fort Gordon, Georgia (2011-2013), and nine years (2013-2020) as the Chief and Program Director of the San Antonio Military Medical Consortium (SAMMC) Oral and Maxillofacial Surgery Residency Program. During his career, COL Jenkins successfully graduated 44 OMS residents, 42 of which obtained board certification. There are an additional 17 residents that he is actively involved with, bringing his total to 61 residents who have benefitted from his passion as an educator.

COL Jenkins is a diplomate of the American Board of Oral and Maxillofacial Surgery (ABOMS) and is a fellow of the American Association of Oral and Maxillofacial Surgeons. He has served as the Army OMS Alternate Delegate to the American Association of Oral and Maxillofacial Surgery from 2010-2019. COL Jenkins was awarded The Surgeon General's "A" Designator, and is a member of the Order of Military Medical Merit.

COL Jenkins is married to Rosie Jenkins and they have two sons, Christopher and James. 

# DENTAL HEALTH COMMAND – ATLANTIC UPDATE CONTINUED FORT EUSTIS DENTAL ACTIVITY: DENTAL HYGIENE RODEO

Fort Eustis Dental Activity (DENTAC) performed a "Dental Hygiene Rodeo" in October at Tignor Dental Clinic to mitigate the several months of "class 4 exam only" treatment due to COVID-19 restrictions. The concept of the Dental Hygiene Rodeo was created to lower the dental classification of over 500 dental class II Soldiers with prophy only needs to dental class I. The Dental Hygiene Rodeo provided 243 Service members with hygiene appointments, which increased wellness to 39.5%. Teamwork within the DENTAC demonstrated the willingness to serve. Although the Dental Hygiene Rodeo week was the focus for most Fort Eustis providers, Tignor Dental Clinic concurrently supported the First Time Dental Readiness (FTDR) mission by treating 51 Soldiers, caring for sick call, providing endodontics and oral surgery services.

Cooperation of the entire DENTAC was required for success of the Dental Hygiene Rodeo plan. The First Sergeant contacted the identified units and gained the needed commitment to participate from unit leadership. Dental staff identified specific patients, pulled charts and scheduled the needed prophys by name. The Commander, most dentists, hygienists, and X2s performed prophys. A COVID-19 reception/screening station was staffed at the front door. Sterilization was appropriately staffed and provided additional help to distribute sterilized instruments.

The Dental Hygiene Rodeo schedule consisted of sixty minute hygiene only appointments for permanent party. No Hygiene-Exam appointments were scheduled. No routine operative or pros care was provided. Each provider treated six to seven hygiene patients per day with the last hour of the day saved for admin and chair clean time.

Prophys performed were non-aerosol generating procedures. A sixty second pre-rinse, hand scaling, toothbrush polish, and fluoride varnish with OHI were performed. Due to the PSRs of 1 and 2, extensive calculus was not expected. If the patient did have extensive calculus that needed more attention, the patient was rescheduled. Proper personal protective equipment was supplied.

Fort Eustis' out of the box thinking has improved Soldier readiness and wellness ensuring the Department of Defense has a medically ready force. One team one fight. Crown the Brave.

#### AOC SPOTLIGHT: 63P ORAL AND MAXILLOFACIAL PATHOLOGY CONTINUED

With forensic dentistry training a part of the 63B residency curriculum (and the choice of some one-year AEGD programs), oral pathologists can also support the local DENTAC forensic dentistry training needs. As the Individual Critical Task Lists (ICTLs) continue to mature, "Perform a postmortem dental examination/forensic identification" (081-000-2729) is one of the 63A tasks (and therefore applies to all AOCs except 63N). The 63P community can support initial and sustainment forensic dentistry training at the DENTAC level to satisfy that readiness requirement. For example, this summer forensic dental identification training was conducted for the 502d Dental Company Area Support at Ft. Hood in support of their deployment.

The following current forensic dental identification forms (hyperlinked) should now be used: Antemortem Dental Record, Postmortem Dental Record, and the Dental Identification Summary Report. These Office of the Armed Forces Medical Examiner forms should be familiar to those who have had Army, Navy, or Air Force forensic dental identification training. The modification from the previous forms includes the FDI World Dental Federation tooth numbering system (if needed for a NATO or an international scenario). In addition, the forms are PDF fillable for electronic use although a printed hardcopy of the forms can also be used. The previous AF 1801 Postmortem Dental Record, AF Form 1802 Antemortem Dental Record, and AF Form 1803 Dental Identification Summary Report forms can also be used until supplies are exhausted. If DENTAC forensic dental officers are not able to access the newer revised forms through the bulletin, notify one of the 63Ps so the forms can be forwarded.

Some of the duties Army Oral Pathologists perform that may not be well-known include serving at the Defense POW/MIA Accounting Agency (DPAA), Joint Base Pearl Harbor-Hickam. The agency identifies the remains of previously unidentified US service members from the conflicts of WWII, Korea, and Vietnam. Forensic dental analysis plays a crucial role in the identification and LTC Rachelle Retoma is currently fills that role. Army oral pathologists also perform forensic dental identifications for the Armed Forces Medical Examiner at Dover Air Force Base on the remains of US service members from currently deployed operations and/or training mishaps. An example is two Army oral pathologists participated in the identification of eight Marines who died in an amphibious assault vehicle (AAV) training accident over the summer. The 63Ps conduct forensic dental identifications as requested for hospital autopsies at installations where 63Ps are assigned. (The DENTAC forensic dental identification teams do a great job in that role at hospitals where there is no 63P assigned.) Oral pathologists attend hospital tumor boards to provide diagnostic support to oral surgery, otolaryngology, radiation-oncology, and hematology-oncology in the treatment planning of cancer patients. Oral pathologists conduct immediate frozen-section pathology diagnosis during hospital operating room procedures in support of oral surgery and otolaryngology. 63P also conduct training for our physician pathologists colleagues to increase their understanding and diagnostic capability for oral pathology entities.

#### AOC SPOTLIGHT: 63P ORAL AND MAXILLOFACIAL PATHOLOGY

Oral and maxillofacial pathologists (63Ps) are the Army's dental specialists addressing the nature, identification, and management of diseases affecting the oral and maxillofacial regions. The assignment authorizations are located at major medical centers to support the clinical, diagnostic, educational, and treatment needs of oral and maxillofacial surgery (63N) residencies, comprehensive dentistry (63B) residencies, other graduate dental education programs, and the Army Dental Corps at large. Oral pathologists are also the Department of Defense's subject matter experts in forensic dentistry. We support oral pathology and forensic dentistry training requests at dental activities (DENTAC's) dental residency programs, and federal services dental education symposiums.

The current locations of 63P authorizations and the dentists assigned there are as follows.

Fort Bliss: MAJ James McCann

Fort Bragg: MAJ Parth Mewar

Fort Gordon: LTC Jennifer Hawie

Fort Hood: (Currently Vacant)

Joint Base Lewis-McChord: LTC Heather Olmo

The two vacant 63P authorizations at Ft. Hood and Hawaii are expected to be filled in the summer of 2021 as two new graduates from the oral pathology residency will enter the inventory.

Although the COVID-19 pandemic limits the ability to perform in-person training at some locations, educational objectives can still be met via tele-conference with platforms such as Microsoft Teams. This past fiscal year, oral pathology and some forensic dentistry training was performed virtually via remote electronic means to include collaboration with Air Force oral pathology. Oral pathology training was also provided virtually to the Naval Post Graduate Dental School and the Walter Reed General Practice Residency program.

Army oral pathologists can also provide tissue specimen and radiographic pathology diagnostic consults, diagnosis clarification, and second opinions as requested. For installations that do not have an oral pathologist but would like one to review a case or suspected pathology, reach out to one in the list above with a request. The radiographs can be sent electronically and the oral pathologist can assist in getting any tissue specimen slides sent to them.
